SINCE 2011, 1,125 VETERANS, TRANSITIONING SERVICE MEMBERS, AND WOUNDED WARRIORS HAVE GRADUATED WITH 12,794 NATIONALLY RECOGNIZED CREDENTIALS IN WELDING AND MACHINING. GRADUATES ARE NOW WELDERS, FABRICATORS, COMPUTER NUMERICALLY CONTROLLED (CNC) MACHINISTS, 3D PRINTERS, CNC MILL AND CNC LATHE OPERATORS, MACHINERY REPAIR TECHNICIANS, ROBOTIC PROGRAMMERS, COMPUTER-AIDED DESIGNERS, AND CNC PROGRAMMERS THROUGHOUT AMERICA. THE ADVANCED MANUFACTURING TRAINING FOR YOUNG VETERANS ASSISTS VETERANS WITH SUCCESSFULLY TRANSITIONING FROM MILITARY SERVICE TO BEGIN CAREERS IN THE U.S. ADVANCED MANUFACTURING INDUSTRY. WORKSHOPS FOR WARRIORS MEASURES ITS SUCCESS BY THE NUMBER OF VETERANS GRADUATING, CREDENTIALS EARNED BY GRADUATES, THE JOB PLACEMENT RATE WITHIN THREE MONTHS OF GRADUATION, AND THE STARTING SALARY OF GRADUATES. FILLING VACANCIES IN THE ADVANCED MANUFACTURING INDUSTRY WITH SKILLED WORKERS WILL RESULT IN A STRONGER U.S. ECONOMY. DURING 2023, ANTICIPATED MEASURABLE OUTCOMES INCLUDE: - 145 STUDENTS WILL ENROLL, COMPLETE THE TRAINING, AND GRADUATE- 10% INCREASE IN WOMEN VETERANS IN THE PROGRAM- 1,000 AMERICAN WELDING SOCIETY, NATIONAL INSTITUTE FOR METALWORKING SKILLS, MASTERCAM, AND/OR SOLIDWORKS CREDENTIALS WILL BE EARNED BY STUDENTS- 136 OR 94% OF GRADUATES WILL BE PLACED INTO JOBS WITHIN THREE MONTHS GRADUATES WILL EARN A STARTING SALARY OF \$60,000 ON AVERAGE. FOR LOW-INCOME VETERANS STRUGGLING TO MAKE ENDS MEET, LIVING STIPENDS PROVIDE A VITAL SOURCE OF FINANCIAL SUPPORT ALLOWING THEM TO PURSUE AN EDUCATION AND STILL PROVIDE FOR THEMSELVES AND THEIR FAMILIES. SCHOLARSHIPS AND LIVING STIPENDS ARE OFFERED TO STUDENTS UNABLE TO PAY FOR HOUSING AND/OR TUITION. LIVING STIPENDS HELP THE VETERAN FOCUS ON STUDIES AND NOT SURVIVAL. STIPENDS CAN BE USED FOR HOUSING, GROCERIES, TRANSPORTATION OR CHILDCARE; THEY REMOVE BARRIERS FOR LOW-INCOME VETERANS TO ACHIEVE SUCCESS. TO DETERMINE SCHOLARSHIPS AND STIPENDS, THE DIRECTOR OF OPERATIONS ASSESSES THE NEEDS OF EACH STUDENT. VETERANS EXPERIENCING HOMELESSNESS OR WHO LACK BASIC RESOURCES ARE PROVIDED LIVING STIPENDS OF UP TO \$2,500 PER MONTH. THE SUPPORT HELPS THEM MAINTAIN HOUSING, BUY GROCERIES, ASSISTS WITH TRANSPORTATION AND CHILDCARE. IN 2022, WORKSHOPS FOR WARRIORS PROVIDED \$1,725,000 IN SCHOLARSHIPS TO VETERANS WHICH INCLUDED 131 FULL-TUITION SCHOLARSHIPS, 2 PARTIAL SCHOLARSHIPS, AND 22 HARDSHIP STIPENDS. IN 2023, WORKSHOPS FOR WARRIORS IS PROJECTED TO PROVIDE 65 SCHOLARSHIPS TO STUDENTS WHICH EQUATES TO \$1,625,000.
